Roll Over accident and Safety Devices in 2006



The operator was travelling with his agricultural tractor connected to a trailer. Due to a sudden depression of the ground the tractor rolled over and the operator remained crushed beneath it.

The tractor was not equipped with a ROPS and a restraint system.






While working with tractor in the field he lost the control sliding on the grass and rolling over three times.


The tractor was not equipped with safety belt.




Roll Over Risk Reduction

Unsafe condition: roll-over protective structure (ROPS) is not installed, or, in the case of two post front mounted foldable ROPS, it is disabled by the operator in order to carry out some particular duties (e.g. in vineyards).








