WP 3: TECHNICAL ADVISORY BOARD FOR THE MANAGEMENT OF THE MARINE RESOURCES

Type of the Adriatic Advisory Board.

The constitution of the **Adriatic Advisory Board - A.A.B.** (Technical Advisory Adriatic Table), one of the cornerstones of the project ECOSEA, by means of the table you can actually tackle some of the major problems of fisheries and co-management of natural resources, according to a shared approach. Starting from this common framework, the project can then act in parallel by putting in place actions to improve the quality of the Adriatic and the mitigation of adverse environmental effects resulting from fishing activities.

Functions.

The A.A.B. provides a guide on the promotion of sustainable management of fisheries, from the point of view of the environmental and socio-economic development within the framework of the Common Fisheries Policy.

It can be regarded as the operational arm of the Steering Committee of the project.

Its activity is functional and underpins all project activities, in particular:

- Implementation of the instrument FISH.Gis (WP3);**
- Pilot projects aimed at increasing biodiversity in the Adriatic Sea(WP4);**
- **Identification of areas for Nursery and for Resettlement Groups(WP5);**

Composition:

The A.A.B. is composed of:

- Three scientific representatives of the three countries involved (one for Italy, one for Albania, one for Croatia) selected by mutual agreement between the partners of the same nationality.
- A representative designated by each partner, for a total of nine representatives from the field of scientific research or by the institutions, or the productive sector (in the latter case, the representative of the production sector can be qualified expression of the sector, for example can be a representative of the fish operators, President of O.P., etc .)

The activities of the table will be coordinated by a coordinator appointed on the proposal of the table, by the Steering Committee.

The Coordinator will become, therefore, a figure of reconciliation between the Steering Committee and **the A.A.B.**

The local tables

To ensure the participation and representation of local actors to **the A.A.B.**, each partner will organize at the local level **one technical tables for each** that will consist of: a representative of the Partner project with also functions as coordinator, operators of the fishing sector, and / or the production sector and / or the academic and scientific research.

The composition of the table can be supplemented by the presence of a representative from the different institutional partner of the project.

The A.A.B. will suggest a minimum agenda to be faced by the local tables.

The components of the local tables will choose the time and the manner of convocation / meeting.

Timing and location of the **foreseen meetings**

The meetings of **the A.A.B.** would be held, approximately, to coincide with those of the Steering Committee. Then it will be held **seven meetings** of **the A.A.B.** throughout the project.

The locations of the meetings will be therefore: **Venice**, Tirana, Ancona, Zadar, Bari, Rijeka, Bologna and **Friuli Venezia Giulia**.
